Online applications are invited from eligible candidates of Union Territory of J & K for engagement against the following positions on Academic Arrangement Basis under S.O. 364 of 2020 dated: 27.11.2020 for a period of six months only or till the posts are filled up by the competent authority, whichever is earlier on the terms and conditions listed below:

01	Jr. Grade Nurse	Diploma in General Nursing and Midwifery/B.Sc Nursing from any recognized Institution/State Medical Faculty/ J&K Paramedical Council.
02	Jr. Theatre Assistant	10+2 with Science or above qualification with minimum two years Diploma/Degree in Operation Theatre Technology Course from any recognized Institution/State Medical Faculty/J & K Paramedical Council
03	Laboratory Assistant	10+2 with Science or above qualification with minimum two years Diploma in Laboratory Assistant Course or having Degree in Medical Lab. Technology Course from any recognized Institution/State Medical Faculty/State Paramedical Council.

Terms & Conditions:-

1	Nature of engagement	The engagement against the advertised posts shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the engagees for regular appointment against these posts which shall be made strictly in accordance with the relevant recruitment rules.

2	Period	For a period of six months or till the posts are filled up by the competent authority whichever is earlier.
3	Salary	The engagee shall be paid salary at the minimum of pay scale in accordance with S.O 364 of 2020 dated: 27.11.2020.
4	Agreement	The selected candidates shall have to enter into an agreement with this Institution to the effect that they will not leave the job before the completion of six months contract. Abandoning/terminating of the agreement, as the case may be, will require one month's prior notice on either side failing which the salary will not be paid for one month to the incumbent which shall always remain in deposit with the department and shall be released on completion of sanctioned term.
5	Age	The age of the applicant at the time of submission of application must not be:- i) Below 18 years; and ii) Above 63 years

Note=

1. The candidates must be in possession of all required documents on 06.04.2022 and no document/certificate issued beyond the cutoff date shall be accepted/entertained.
2. In case of large number of applications, the candidates shall be shortlisted for the written test as per availability of space/resources.
3. The selection shall be made purely on the basis of merit obtained by the candidate in the written test (to be held subsequently).
4. In case any post of the aforesaid categories gets filled up on regular basis during the intervening period from the date of issuance of notification to the date of selection, such posts shall be deemed to have been withdrawn/deleted from the notification and the final selection shall be made as per availability of posts at the time of selection.
5. In case of tie in the merit obtained in the written test the following procedure shall be followed to break the tie:-
 - i) **In case of tie between Post Graduates and graduate candidates, the Post Graduates candidates will be given preference.**
 - ii) **In case of tie between two or more Post Graduates the candidates having secured higher percentage of marks in PG Degree will be preferred.**
 - iii) **In case of tie between two or more Graduates the candidates having secured higher percentage of marks in Graduation will be preferred.**
 - iv) **In case of tie between Graduates and Diploma holders, the Graduate candidates will be given preference.**
 - v) **In case of tie between Diploma holders, the candidate having higher percentage of marks in the Diploma Course will be preferred.**



Instructions for applying online:-

- a. The necessary instructions for filling-up of online form and submission of fees details shall be available on GMC, Sgr. website (www.gmcs.edu.in).
- b. Separate links for filling up of online application form shall be available on the official website of GMC, Sgr. W.e.f 28.03.2022 (10.00AM onwards).
- c. Candidates are required to apply online through the official website of GMC, Sgr. only.
- d. The requisite original documents including domicile certificate issued by the competent authority on the format prescribed for the purpose must be produced at the time of document verification, or as and when sought by GMC, Sgr.
- e. The candidates are required to upload the images of their recent photograph and specimen signature which should be uploaded in (Jpeg) format only.
- f. Candidates have to deposit fee of Rs. 300/- through online mode only i.e through Net Banking/Debit Card/Credit Card.
- g. Applications of those candidates will not be considered who do not pay the fee in online mode.
- h. Candidates must take a print out of the application form and fee receipt after successful filling up of the application form.
- i. Candidates cannot edit their application form after submission.
